## RESOLUTION NO. 22-31 of 2022

A RESOLUTION OF THE COUNCIL OF THE MUNICIPALITY OF NORRISTOWN AWARDING A CONTRACT NOT TO EXCEED THE AMOUNT OF \$23,000.00 TO SELEX ES, INC., FOR THE PURCHASE AND INSTALLATION OF A 3 CAMERA ALPR SYSTEM ON THE ROOF OF NPD VEHICLE 52-37, A FORD F-150 EXTENDED CAB MARKED POLICE VEHICLE. PURCHASE WILL INCLUDE 2 YEARS ADDITIONAL EXTENDED WARRANTY AT \$1,845.00 PER YEAR, INCLUDED IN QUOTE.

WHEREAS, under §4-35 of the Administrative Code the Municipality is permitted to enter into contracts for purchases pursuant to the thresholds in the Administrative Code as amended from time to time and set forth in the Pennsylvania Department of Labor & Industry Bulletin; and

WHEREAS, under §4-35 all contracts for purchases in excess of \$21,900 must be awarded to the lowest responsible bidder after due advertising unless the contract does not require competitive bidding because competitively bid; and

WHEREAS, under §4-35 the Director of Finance has certified to the Municipal Administrator that sufficient unencumbered funds are available for the purchase as authorized by the budget; and

WHEREAS, under §4-35 all contracts in excess of \$21,000 must be in writing and must be awarded by Municipal Council and executed by the Municipal Administrator; and

WHEREAS, the Municipal Solicitor has reviewed all relevant purchase and contract documents;

**NOW THEREFORE BE IT RESOLVED** that the Council of the Municipality of Norristown hereby approves the purchase as being in the best interests of the Municipality and authorizes the Municipality to enter into an agreement with Selex ES, Inc., for the purchase of a 3 camera ALPR, including installation and 2 years extended warranty, to be installed on NPD Police vehicle 52-37, assigned to Parking Enforcement as a marked patrol truck.

**BE IT FURTHER RESOLVED** that the Municipal Administrator and the Director of Finance, or their designees, are authorized to take all necessary actions to complete the purchase including execution of the Agreement and any related documents.
