RESOLUTION NO. 22-57 OF 2022

**A RESOLUTION OF THE MUNICIPALITY OF NORRISTOWN,
MONTGOMERY COUNTY, PENNSYLVANIA, APPROVING AN
AMENDMENT TO THE NORRISTOWN CIVIL SERVICE RULES AND
REGULATIONS AND RELATING TO APPLICATION PROCEDURES
FOR ENTRY LEVEL POLICE OFFICERS.**

WHEREAS, the Norristown Municipal Council has appointed a Civil Service Commission to serve the Municipality as required by law; and

WHEREAS, THE Norristown Civil Service Commission (“Commission”) has promulgated Rules and Regulations that govern the operation of the Civil Service Commission (“Rules and Regulations”) that may be amended from time to time by the Commission with the approval of Municipal Council as required by law; and

WHEREAS, on August 9, 2022, the Commission adopted a resolution amending the Rules and Regulations, specifically addressing the appointment of Industrial/ Organizational Solution to conduct written examinations for applicants for entry level police officer; administration by police supervisory personnel appointed by the Chief of Police of oral examinations and physical agility tests; advertisement of applications for the position of entry level police officer; written notice of written examination results; and, ranking of all passing applicants and the creation of an eligibility list for the position of entry level police officer; and

WHEREAS, Norristown Municipal Council desires to approve the amendments as being in the best interest of the health, safety, and welfare of the residents of the Municipality and the public safety in general;

NOW, THEREFORE, BE IT RESOLVED by the Members of Council of the Municipality of Norristown, that Municipal Council hereby approves the attached Resolution of the Civil Service Commission of the Municipality of Norristown, dated August 9, 2022, as attached hereto as Exhibit “A,” and authorizes execution of same by Council President and also authorizes the


Municipal Administrator, or his designee, to carry out all necessary actions in furtherance thereof; and

BE IT FURTHER RESOLVED that all resolutions or parts thereof inconsistent with this Resolution are hereby repealed to the extent of the inconsistency; and that the provisions of this Resolution are declared to be severable so that any provision determined to be invalid or unconstitutional by a court of competent jurisdiction shall have no effect and shall not invalidate the remaining provisions of this Resolution or the Rules and Regulations of the Norristown Civil Service Commission; and that this Resolution shall be effective immediately upon its adoption.
